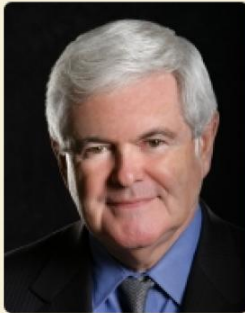

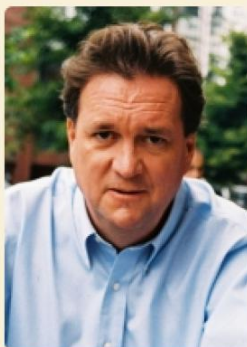
The Honorable Newt Gingrich, Former U.S. Representative and Speaker of the House, historian, author and political consultant
